Addiction Medicine ECHO Program

The OHSU Addiction Medicine Section, Oregon Rural Practice Based Research Network (ORPRN), and Oregon ECHO Network offer a range of Addiction Medicine ECHO learning collaborative programs funded by the SAMHSA State Opioid Response grant program. <https://www.oregonechonetwork.org/addictionmed>. Since 2017, Oregon's Addiction Medicine ECHOs have increased the substance use disorder-care workforce capacity, encouraged implementation of evidenced-based best practices, and supported individuals across the state by providing a learning community to exchange ideas and reduce professional burnout. The Addiction Medicine ECHO Program is communicating with national experts in Deflection best practices and implementation, and is now excited to support the implementation of HB 4002 and creation of local Deflection programs. Forensic Intensive Treatment Team (FITT)

The Forensic Intensive Treatment Team (FITT) is an innovative team designed to support some of the most complex justice-involved behavioral health individuals in Lane County. The team is staffed with Peer Support Specialists, QMHA Court Liaisons, QMHA Case Managers, Senior Office Assistant, Licensed Medical Practitioner, Qualified Mental Health Professionals (both Mental Health and Substance Use), and a Clinical Supervisor. All clients participating in FITT services engage in the program voluntarily. The program is 100% grant funded by the Oregon Criminal Justice Commission. The FITT services are delivered primarily in the community. This includes street outreach, jail in-reach,

hospital in-reach, outreach to unhoused communities, and home visits. This includes, when appropriate, co-responding to FITT clients with law enforcement. There is an option for office-based, drop-in, or telehealth services as needed. FITT has the goal of reducing the client's involvement with the criminal justice system and the frequency with which they rely on emergency medical services by increasing the availability of effective community-based supports and services.

Mr. Jalabert has over 21 years of experience in the behavioral health field. He currently works at Lane County Behavioral Health (LCBH) in Eugene Oregon as the clinical supervisor of the Forensic Intensive Treatment Team (FITT) and a Police Co-Responder Program. He is a Licensed Clinical Social Worker, Master Addiction Counselor, and Certified Alcohol Drug Counselor III. He holds a Bachelor of Arts in Humanities, Master of Social Work with a focus in Health/Mental Health, Master of Business Administration with a focus in Healthcare Management, and a Graduate Certificate in Biomedical Informatics. He has a depth of experience working as a behavioral health professional in criminal justice settings.

Acadia

Acadia Healthcare's Comprehensive Treatment Centers are a beacon of hope for individuals grappling with behavioral health and addiction issues. We provide medication assisted treatment and counseling interventions for those struggling with opioids in an outpatient setting. We have 7 locations across Oregon (Marion County, Jackson County, Multnomah County, Washington County, Linn County) with an additional mobile unit, currently operating out of Hillsboro. Our Comprehensive Treatment Center teams are comprised of counselors, nurses, medical providers, and peer supports.

The Oregon Judicial Department (OJD) includes the circuit courts located throughout the state. Circuit courts will play a key role in implementing HB 4002 by deciding whether arrested persons are held or released before trial, adjudicating charges under the new drug enforcement misdemeanor (DEM), and in sealing records as specified by the new law.

Ideal Option

Ideal Option was founded in 2012 and has treated more than 75,000 patients Nationwide. Our goal is to deliver cost-effective, outcomes-based addiction treatment that improves patients' lives while materially reducing the financial and social burden associated with untreated, or ineffectively treated, substance use disorder. In Oregon, Ideal Option currently has clinics in 6 counties. In Deschutes Marion Counties, Ideal Option prescribes and distributes medications to individuals in custody with an Opioid Use Disorder and transition folks to a community-provider upon release. We operate a nurse hotline Nurse Care Team, to assist patients and others with treatment adherence. We offer same-day service with no waitlists to facilitate a swift start to recovery. Our data underscores the effectiveness of our approach: 63% of patients who returned for a second visit remained in treatment after 6 months. After six months, patients have typically progressed to the maintenance stage of care in which medication adherence and illicit substance abstinence has been verified. Impressively, 96% of patients in treatment for 6 months or longer also report no drug-related arrests or charges since starting treatment.

AOCMHP Mobile Crisis Training Academy

This foundational mobile crisis training academy is offered virtual or in-person for new mobile crisis responders and supervisors, including QMHPs, QMHAs, Peer Support Specialists, and EMS workers. The core curriculum is presented by several subject matter experts and covers many of the training requirements in OAR 309-072-0120 (c), including de-escalation, crisis and safety planning, suicide risk screening, trauma-informed response, harm reduction techniques, and specialized responses for culturally specific groups and for people with co-occurring disorders. We also offer deeper dive specialty modules for crisis responders interested in learning more about particular crisis response topics.

Additional Trainings for the Behavioral Health System Workforce and Other Systems - AOCMHP offers a variety of suicide prevention, intervention, postvention and mental health treatment training programs through grant funding from OHA, including Mental Health First Aid for public safety officers among others, Motivational Interviewing, and a number of trainings to advance clinical skills, such as Dialectical Behavior Therapy and Cognitive Behavioral Therapy. Our training programs, including trainings for trainers, are available to the public behavioral health system workforce as well as to workers from other systems. The purpose of these trainings are to advance knowledge and skills of the workforce to prevent bad outcomes and improve the health and wellbeing of their community members across Oregon.

Behavioral Health Services (BHS) in the Oregon Department of Corrections (ODOC)

The BHS provides a variety of treatment services to adults in custody (AICs) with treatment need. These include Alternative Incarceration Programs, a Co-Occurring Disorders treatment program, Substance Use Disorder (SUD) treatment programs, and Problem Gambling treatment. Through these various programs, treatment is available at 6 of ODOC's correctional facilities. Beginning with a pilot program at Coffee Creek Correctional Facility (CCCF) in 2022, the ODOC introduced a chronic disease model of SUD treatment, which provides services to AICs with treatment need at any time during their incarceration. Alongside Certified Alcohol and Drug Counselors, this program utilizes AIC Certified Recovery Mentors as part of the service delivery model. These CRMs receive OHA-recognized training and receive ongoing supervision and training throughout their work in the treatment program. They release as actively credentialed CRMs with the Mental Health and Addiction Certification Board of Oregon with most seeking direct employment in the field upon release. Currently, the ODOC facilities utilizing the skills of AIC CRMs are Columbia River Correctional Institution, CCCF, Oregon State Correctional Institution, and the Oregon State Penitentiary (OSP). In the summer of 2024, the chronic disease model of SUD treatment services expands to AICs at the OSP and Snake River Correctional Institution.
