## **ECHO** Through the Years



- 2017: HB3440
  - Prohibited first 30 day PA for Bup (Suboxone)
- 2018: HB4143
  - Commissioned report barriers to Bup / MAT
- 2019: HB2257
  - Removed MAT PAs for Oregon Health Plan
- 2022: MAT act passed congress
  - All med providers can now prescribe Bup (Suboxone)









Now: 11 different programs



- Advises across 6 deflection pathways; all approaches
- TA partnership to > 75 deflection sites nationally
- Serve as the DOJ Bureau of Justice Assistance (BJA) National Deflection TA Center
- Partnered with IL statewide Deflection Initiative: all 102 counties





# **TA Elements and Timeline**



# Early Summer 2024

- OHSU-ORPRN team will provide logistical support and planning to organize local training event(s) by CHJ
- CHJ will deliver in-person (day long workshop) to launch the Deflections Solutions Action Plan (DSAP)
  - 3 regional workshops
  - Approx. 5 key leaders per county deflection team, identified with Deflection Coordinator agency

**Deliverable:** Each county team will have a written, actionable, working DSAP document for next steps



# Mid Summer 2024 - May 2025

- CHJ separately trains OHSU-ORPRN team for proceeding to Phase II and III (implementation activities)
- OHSU-ORPRN continuing TA, supporting the implementation of the DSAP plan
- CHJ providing ongoing support for first year



### Year 2 Technical Assistance

- OHSU-ORPRN team assists with continuous quality improvement
- Informed by CJC Best Practices Report
- Integrating new Deflection partners with new infrastructure investments

# Supplemental Slides



#### **County Team TA**

- Each County Team can opt in to low-, medium-, or highlevel TA support
  - Low: Access to learning collaboratives (ECHOs) and library of deflection education materials
  - Medium: 1 hour monthly of TA with SME & Coach
  - High: 30-minute weekly or 60-minute bi-monthly TA
     with SME and Deflection Coach



## Content of ongoing TA for the biennium

- Scale up and contextualize national models
- Setting up workflows and referrals across agencies
- Sensitive data handling across electronic systems
- Identify needs for culture change, and guiding culture
- Hold accountable to program goals and advancing these
- Debrief deflection cases for group reflection and QI
- Identify success stories and show the value of the work of each team member, to other team members (build mutual respect)
- (Yr 2) Integrating CJC Best Practices to further advance
- (Yr 2) Expansion for new infrastructure
